SANCTION: Held under the sanction of USA Swimming, Inc., issued by North Carolina Swimming, Inc. Sanction No. NC09005

FACILITY: The Sportsplex is a ten lane, 25-yard course with non-turbulent lane ropes. The Colorado Electronic Timing System with horn and strobe start will be used. There is a separate pool for continuous warm up and cool down. **Industrial fans will be used to improve facility air quality.**

RULES: The meet will be conducted in accordance with the USA Swimming Rules and Regulations and the NCS Official Handbook and NCS Safety program, except where the rules therein are optional and exceptions are herein stated.

ELIGIBILITY: All swimmers must be registered with USA Swimming.

ENTRIES: Entries must be submitted in Hy-Tek Team Manager format.

Entry file may be submitted by e-mail to tbrewer441@aol.com. A print out listing the individual swimmers and their events, all other requested information and payment of entry fees must be submitted for your entry to be considered complete.

ENTRY

LIMIT:

The Meet Director reserves the right to limit entries to comply with the NCS 4-Hour Rule.

Entries are accepted in order of receipt. Only properly completed entry forms with payment of all fees will be accepted. Entry forms and summary sheets not properly completed or submitted without payment will be considered not received.

Swimmers are limited to five individual events per day. A swimmer entered in too many events will be dropped from the first event that is over the limit.

ENTRY

DEADLINE:

Midnight, Wednesday, February 4, 2009.

Late entries will be accepted only at the discretion of the Meet Director. Late entries may not be seeded. We reserve the right to limit or suspend the addition of swimmers or heats to accommodate late entries. Late entries will be charged double fees.

Telephone entries will not be accepted. We will accept calls to correct or modify entries mailed and received prior to the entry deadline.

SEEDING: With the exception of the 400 IM and 500 Free, all events will be pre-seeded. The 400 IM and 500 Free will swim fastest to slowest.

All swimmers in 500 yard freestyle must provide their own timers and counters.

CHECK-IN: In order to be seeded into the 400 IM and 500 Free, swimmers must positively check in with the Clerk of Course. Clerk of Course will close for check-in 30 minutes prior to the end of warm ups for each session.

AWARDS: Individual Ribbons: 1st - 8th Place by age group

SCORING: This meet will not be scored.

SAFETY: The NCS safety program is in effect for this meet. Coaches are advised to closely supervise their swimmers at all times. No running or horseplay will be tolerated. Anyone failing to comply with safety request may forfeit his or her privilege to participate.

MEMBERSHIP:

All coaches and officials on deck must be registered and certified with USA Swimming. Meet Management will require all coaches and officials to show proof of certification/ registration. Coaches and officials shall prominently display their registration cards while on deck.

COACHES'

MEETING: A coaches' meeting may be held at the end of each Saturday warm up session at the referee's discretion.

OFFICIALS'

MEETING: We welcome all certified USA Swimming officials on deck. Please indicate officials on the entry summary form who may be able to help. Please include name, phone number, e-mail (if available), certification level, and sessions available.
